

# Agreement for Electric Service

This **AGREEMENT** is made by and between the Gila River Indian Community Utility Authority (GRICUA) and x \_\_\_\_\_  
(the "**Applicant**").

**WHEREAS**, GRICUA is authorized by the Gila River Indian Community to provide electrical services; and

**WHEREAS**, The undersigned Applicant hereby agrees that GRICUA will deliver electric energy to and for the equipment hereinafter described, at the location shown below, in accordance with the applicable rates and rules of GRICUA.

**NOW THEREFORE AND IN CONSIDERATION** of these promises and of other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. GRICUA has made available for inspection its applicable Rules and Regulations for Electrical Service (hereinafter also referred to as "Rules and Regulations"). Applicant agrees to comply with the Rules and Regulations unless otherwise indicated within this Agreement and with any changes or modifications thereto which may be authorized from time to time.
2. Applicant's attention has been directed to the rate schedules applicable to the service herein described, and Applicant has elected to take and pay for service under Schedule E902.
3. Applicant hereby grants to GRICUA a service line right-of-way for any and all electric lines and/or facilities, which may be necessary to build in, on, under or over Applicant's premises for the purpose of making delivery hereunder. If rights-of-way on other properties are required for the line extension, Applicant shall obtain these rights-of-way per section 5.1 of GRICUA's Rules and Regulations.
4. In the event Applicant materially increases or decreases his electric service requirements from those proposed hereunder and a change is made in GRICUA's facilities, a new Agreement for Electric Service shall be made for the installation and removal cost of the facilities, if any.
5. Applicant is providing the following information to permit GRICUA to determine facilities required to provide service.

Electric Service Voltage 120/240 Volts  
Electric Load 7kW      Est. Max. Demand 7kW  
Electric Main Service Rating 200 amperes

6. Deposit on Electric Account

Section 4 of the Rules & Regulations covers the conditions relevant to deposits. A deposit may be required for each electric account. The amount of the deposit shall be calculated according to Section 4 of GRICUA's Rules & Regulations. The Applicant agrees to pay the following deposit to secure payment of the account. Deposits may be assessed at any time per the Rules & Regulations.

Amount of initial deposit required for this account: \$0

7. Payment Assistance

For residential customers, the Applicant hereby authorizes GRICUA to contact the District Service Center (“DSC”) if bills are not paid on time to determine if the Applicant has contacted the DSC for payment on Applicant’s behalf. This does not release the Applicant from paying their bills on time nor does it limit GRICUA’s remedies for non-payment.

8. Disputes

Disputes that arise under this Agreement shall be resolved pursuant to Section 2.1.8 of the GRICUA Rules and Regulations for Electrical Service.

9. GRICUA Rules and Regulations for Electrical Service:

The GRICUA Rules and Regulations for Electrical Service are hereby incorporated by reference into this Agreement; provided, that if the provisions in the Rules and Regulations are in conflict with this Agreement, the terms of this Agreement shall control.
